War," Mr Snowdon said.

Planning is now underway to repatriate Private Fisher's remains home to Australia.

Private Fisher is the fourth and last Australian Soldier to be located and his return will complete the recovery of all Australian Army personnel who were lost on operations and not recovered during the Vietnam War. Lance Corporal Parker and Private Gillson were repatriated to Australia in June 2007 and Lance Corporal Gillespie in December 2007.

Two Royal Australian Air Force personnel, Flying Officer Michael Herbert and Pilot Officer Robert Carver remain unaccounted for from the Vietnam War.

Inquiry into Eligibility Criteria for the Australian Defence Medal **Terms of Reference**

The Defence Honours and Awards Tribunal shall inquire into and report on the eligibility criteria for the Australian Defence Medal.

The Australian Defence Medal, instituted by Letters Patent, dated 8 September 2005 and as amended on 20 March 2006 by the *Australian Defence Medal Regulations 2006*, recognises efficient Australian Defence Force (ADF) service since 3 September 1945.

Having regard to the purposes for which the Australian Defence Medal was instituted and the terms of the *Australian Defence Medal Regulation 2006* ('the Regulation'), the Tribunal is to:

(a) conduct an inquiry into decisions of the Chief of the Defence Force, or his delegate, concerning the eligibility of ADF personnel, as specified in these terms of reference ('the specified ADF personnel'), to be or not to be eligible to be awarded an Australian Defence Medal and make findings and

recommendations in regard to that review;

(b) examine any other circumstance, arising since 3 September 1945, where the services of ADF personnel have been, or could be, involuntarily terminated and the eligibility of such personnel to be awarded an Australian Defence Medal;

(c) examine the powers of the Chief of the Defence Force, to determine whether an ADF person 'has given qualifying service that is efficient service' and is therefore eligible to be awarded an Australian Defence Medal;

(d) report to the Parliamentary Secretary for Defence on its findings in regard to the above and any recommendations that arise from the inquiry. The Specified ADF personnel for the purposes of (a) above are:

(a) Defence Force personnel, who meet the minimum period of service as prescribed under the Regulation, but the period of service commenced prior to 3 September 1945;

(b) Mobilised wartime naval reservists, who, in or about 1947, accepted a two year engagement in the Royal Australian Navy and exercised their right to opt for a free discharge after the first 12 months of service.

(c) Defence Force personnel who were women and who were discharged:

- i. prior to 1969 on grounds of marital status;
- ii. prior to 1974 on grounds of pregnancy;

(d) National Servicemen, who do not meet the minimum period of service as prescribed under the Regulation and who elected to be discharged under the provisions of the *National Service Termination Act 1973*;

(e) Defence Force personnel who were discharged:

- i. with a non-compensable illness or injury;

following months used my new found knowledge by doing MAS Reviews of units such as 2/14 LH in Brisbane and 2 Cav Regt in Darwin both of which had plenty of ASLAV. Knowing that there was a requirement for an MAS Review of the Middle East coming up in October I threw my hat in the ring. As there was no other competition I was appointed for that deployment. You can imagine how I felt. Here I was, nearly 57 years old, in my 40th year in the Army and I was finally going on a recognised operation. Anyone who has been a soldier can understand the feeling of satisfaction to finally be allowed to round out my career albeit as a "Chocco". I had made up mind that after what had happened the year before I was not going to believe this until my feet were firmly on the sand in the Middle East. Well of course it did happen and this is a brief account of my experiences in what can only be described as a very dangerous place to visit.

We left Sydney at 1330 flying to Abu Dhabi, then to Kuwait where all personnel entering the Middle East Area of Operations (MEAO) transit for additional training and acclimatisation. Arriving at the Force Level Logistic Asset – Kuwait (FLLA-K) at 0730 the day after we left we were absolutely jet lagged. We were told to get into uniforms and that training would begin after breakfast at 0830. We were not allowed to go to sleep until after 2130 that night. This method actually did work and by day 3 we were fine. The heat was intense made worse by the glare off the sand. We endured 5 days of training including a half a day at the range in 50 degree heat wearing all our body armour and helmets. The air conditioned tents we lived in were a welcome return.

Our day came to move forward into Iraq. The 35 minute C 130 flight to Tallil airbase took about 75 minutes. Tallil was hot, dusty and featureless except

for the unmistakable shape of the 4500 year old Ziggurat. This monolith is about 500 metres from the base and was part of the ancient city of Ur and near the Garden of Eden. We did get to see it close up some days later and amongst the ruins is the house where Abraham was born and grew up. This area is where mankind began and the experience of being there is absolutely overwhelming. The explorational digs have been suspended due to the war. In Tallil, many different coalition forces here including Americans, British, Romanians, Koreans, Estonians, Japanese etc. At night one we are rocketed. The 122 mm rocket assisted rounds really help you wake up! We spent some time in the bunker until the all clear was given. This was the first time I had been bombed and I was hoping it would be the last. This was not to be the case and the next time they were really close. You know they are close when you are running out of the shower block with the loud speaker system saying "INCOMING, INCOMING, INCOMING" and there is a flash somewhere behind you followed by an almighty bang. The dust from the explosion then drifts across you. Apparently these things were fired from 18 km away. Some nights the good guys would open up but they sound just like the bad guys. Same affect though – little or no sleep, with the added constant noise of aircraft during the night.

Next stop was Baghdad. More tactical flying on takeoff and landing. Baghdad is an unreal place. The Australian contingent lives in one of Saddam's palaces and the furniture and decor is surreal and has no connection to a military environment. Camp Victory takes in the airport and all of the palaces all of which are situated around vast lakes. Gum trees, apparently gifts from the Australian Government in years gone by, are everywhere and it almost feels comforting. Thousands of

their evacuation is delayed beyond this time," the surgeon said. "In the frontline war setting, where injuries are more severe than in the civilian setting, military trauma units believe that soldiers must be evacuated within the 'golden 30 minutes' if they are to have a reasonable chance of survival.

"The most common cause of death when evacuation is delayed is bleeding to death in the field - a psychologically devastating outcome for the treating medic looking after the injured soldier at the time."

The ADF said the other two Australian soldiers injured on July 8 had returned to light duties. The third survivor, reported to be a US special forces communication specialist, was gravely wounded.

Defence Home Ownership Assistance Scheme Starts

The Minister for Defence Science and Personnel, the Hon. Warren Snowdon MP, today declared the new Defence Home Ownership Assistance Scheme (DHOAS) officially underway.

The Scheme is a part of a broader set of initiatives to encourage ADF personnel to stay in the Service.

It provides progressively higher home loan subsidies to permanent members who serve beyond critical separation points of four, eight and 12 years, and Reservists with service of eight, 12 and 16 years.

"DHOAS offers real help to ADF members and their families in achieving home ownership in the current competitive housing market," Mr Snowdon said.

The Department of Veterans' Affairs (DVA) has been selected as the Scheme Administrator and will be the initial point of contact for Defence members seeking information on the Scheme and applying for the DHOAS subsidy.

A panel of three Home Loan Providers has been selected to support the DHOAS:

- * National Australia Bank Limited,
- * Australian Defence Credit Union Limited, and
- * Defence Force Credit Union Limited.

They have each undertaken as part of the tender process to offer products equal to or better than available in the general mortgage market.

The Department of Defence, DVA and the three Home Loan Providers will be undertaking an extensive information campaign aimed at informing all ADF personnel of the details of the DHOAS in coming months.

Mr Snowdon said that the Scheme will provide significant benefit for eligible members of the Defence Force.

Helping People Plan For A Post-Military Life

The Minister for Defence Science and Personnel, the Hon. Warren Snowdon MP, recently inspected the Australian Defence Force (ADF) Transition Centre at Lavarack Barracks in Townsville.

The Centre forms part of a new enhanced transition process to help ADF members and their families move smoothly from military to civilian life.

Mr Snowdon said it's important that families can easily access all the available care and advice. The Townsville Transition Centre building also houses other aspects of regional support to ADF members in Townsville.

"I am pleased to see that Defence is providing an environment where the ADF member and their family can discuss, in a confidential manner, all aspects of their transition".

The enhanced transition support service provides separating ADF members and their families with an individually tailored service and accurate, high quality information about issues like rehabilitation and compensation; housing; medical and dental; financial; and family support to ADF members to assist them successfully plan their post-military life.

"Vitality, the new transition service is working actively with other government agencies such as the Department of Veterans' Affairs and Comsuper,".

"There is still work to be done to better support our ADF members as they leave the services, but we hope to have the enhanced transition care implemented nationally by November 2008."
